# About the course

Composites with optimized nano-filler particles and non-bis-GMA resins decrease wear. polymerization shrinkage stress and improve optical qualities. Glass ionomer restorative materials can serve as a therapeutic restorative material, reducing postoperative sensitivity and potential recurrent decay. Predictable class II restorations require specific skills and techniques to achieve reliable success. Patient communication is vital to understanding of treatment options. Selecting and implementing the latest all-ceramic crowns requires knowledge regarding the patient's esthetic expectations, tooth preparation, laboratory fabrication and cementation protocols. These subjects and some you may have never heard about will be presented. This course is an excellent way to update your skills using the latest restorative materials with a common sense approach.

- Become acquainted with new innovative products that improve patient care, such as anesthesia buffering solutions and sonically activated composite systems.
- Learn how to use dental photography and patient communication tools to educate your patients.
- Review the latest all-ceramic crowns, their indications and cementation protocols.

# About the speaker



### Dr. Daniel Ward

Dr. Daniel H. Ward was an Assistant Clinical Professor at The Ohio State University for 13 years and has been in private practice in Columbus, Ohio, for 37 years. He served as lecturer and chief examiner of the Post-Graduate Program in Esthetic Dentistry at the University of Minnesota, SUNY Buffalo, UMKC, and the University of Florida. He is a Fellow in the American College of Dentists, Fellow in the International College of Dentists, Fellow of the American Society for Dental Aesthetics, Fellow in the Pierre Fauchard Academy, and a Fellow in the Academy of General Dentistry. He is an Associate Member of the Academy of Esthetic Dentistry.

Dr. Ward has lectured throughout the world. He was invited to present to the annual meetings of the American Dental Association, Academy of General Dentistry, The Chicago Midwinter Yankee Meeting, the Greater New York Dental Meeting, the California Dental Association, the Ohio Dental Association, the American Society for Dental Aesthetics, the American Academy of Cosmetic Dentistry, the Wednesday, January 10, 2018

International Aesthetic Congress in Istanbul, Turkey, and the UNAM International Congress in Mexico City. He has lectured in India, Poland, Korea, Czech Republic, Austria, Hungary, and numerous dental societies and associations.

Dr. Ward has published articles in the Journal of Prosthodontics, Journal of Esthetic and Restorative Dentistry, Dental Clinics of North America, Compendium of Continuing Education in Dentistry, Dentistry Today, Inside Dentistry, Oral Health, and Contemporary Esthetics and Restorative Practice. He authored the "Test Yourself" columns published in Esthetic Dentistry Update. He is a reviewer for Journal of Esthetic and Restorative Dentistry and the Journal of Prosthetic Dentistry. Dr. Ward has developed a computerized method of smile design called the RED Proportion. An innovative pioneer, Dr. Ward combines theory with practical real world experience.
